This contractual location agreement is made this _____ day of _____, 2011, between Beanstalk Business Services, LLC herein referred to as **The Locator**, and _____, whose address is: _____, and phone number is _____ herein referred to as **The Vendor**. This entire contract is following terms and conditions set forth below and there are no other oral or written representations.

1. The equipment covered by this agreement shall be as follows: ____ Full Sized Snack/Soda Machines, which are ____ " high x ____ " wide x ____ " deep or take up approximately ____ square feet of space.
2. Locations are secured by using telemarketing methods. Each location shall be provided at **the rate of \$500 per located vending machine**.
3. For 20 and less machines, we require full payment upfront; for over 20 machines, we suggest you sign up for 20 at a time.
4. Payment methods accepted are:
 - Check payable to **Beanstalk Business Services, LLC**. Please use Fedex, UPS, or USPS with delivery confirmation to avoid lost or delayed checks.
 - Credit card online at <https://www.businessbeanstalk.com/payments> or by faxing/ mailing in our **Credit Card Authorization Form**
 - PayPal via PayPal.com to payments@BusinessBeanstalk.com
5. **The Locator** will provide a call list of potential locations within **The Vendor's** desired area of operations. **The Vendor** shall approve and return the call list prior to commencement of the location service to remove undesirable locations. It is understood that **The Vendor** agrees to accept all verified locations, and any rejections must be made in writing by faxing or mailing in the *Location Rejection Form*.
6. **The Vendor** understands that there are no guarantees made as far as financial returns to any location secured by **The Locator**.
7. All locations must be attempted to be installed within 7 days of the date the locations are submitted to **The Vendor** via email by **The Locator**, locations which are refused by location management will be replaced free of charge. If no notice is given to **The Locator** within 7 days from when the locations were submitted, it will be considered "accepted" by the vendor.
8. Each location is accompanied by a 45 day guarantee. If **The Vendor's** machine gets rejected or requested to be removed from the locations premises within 45 days of installation, **The Vendor** will fax or mail in the *Location Rejection Form*, and **The Locator** will give one (1) replacement location free of charge.
9. **The Locator** reserves the right to cancel this agreement at any time or if the number of rejected locations exceeds the number of placed locations. In the event of contract cancellation **The Locator** will refund **The Vendor** promptly for any paid locations that have not been submitted. If at any time **The**

Vendor wishes to cancel, un-submitted locations will also be refunded promptly. This is done to protect the interests of both parties. There is a 15% administration fee for refund requests past 45 days of the location being submitted to **the Vendor**, and 10% administration fee for refund requests after the submission of call list to **the Vendor**.

10. The parties have read the terms and agree by signing below. Terms of this agreement are valid for 6 months from sign date or upon completion, whichever comes first.
